

## Annex to the Investment Regulations

The Board of Trustees of the simply3a Foundation (“Foundation”) specifies the securities solutions available to Clients (“product categories”) as follows:

### 1. Target values and margins of available pension products

Insofar as no alternative regulations are expressly stipulated in the benefits agreement, the following margins and/or target values apply to the available product categories and investment strategies. Compliance with the margins shall be monitored by the Foundation on a regular basis.

#### 2.1. Product category “Advisory”

## 2.2. Product category “Asset Management Mandate”

### 2.2.1. Management by the Foundation

Only OPO 2-compliant collective investments are implemented, which is why reference is made solely to the proportion of equities according to the prospectus here.

The proportion of the investment portfolio held in foreign currencies is no more than 30% for the “Income”, “Conservative” and “Balanced” strategies and no more than 50% for the “Dynamic” and “Growth” strategies. Alternative investments are limited to a weighting of 20% under the “Growth” strategy and 15% under all other strategies.

Clients may choose from the strategies specified in the benefits agreement. The margins of the tactical and/or strategic equity share can be defined differently in the benefits agreement. However, differences must not exceed or fall below the following tactical margins for the equity shares.
